This list of restricted bridges on the State Highway System supersedes all earlier bridge weight restrictions lists issued by this office. These restrictions are effective immediately and will be incorporated in the overdimensional permit administrative rules as soon as possible.

* Legal weight as provided under A.R.S. § 28-1100 means:

Single axle weight does not exceed 20,000 lbs or the manufacturer's rating, whichever is less;

Tandem axle weight does not exceed 34,000 lbs;

Gross vehicle weight on a vehicle combination of five axles or more does not exceed 80,000 lbs; and

Overall gross weight on any group of two or more consecutive axles does not exceed the maximum allowable axle group weights computed using the formula prescribed under A.R.S. § 28-1100(A)(4).

Note 1

1. Class A permitted vehicles with a gross weight of:

a. 150,000 lbs or less – no additional restrictions;

b. 150,001 through 250,000 lbs – drivers shall:

i. Coordinate road closures by or under the direction of law enforcement; and

ii. Cross on center of bridge at a constant speed of no more than 10 mph while on bridge.

2. Class C permitted vehicles with a gross weight of over 250,000 lbs require special analysis and approval from the Bridge Group.

Note 2

1. Class A permitted vehicles with a gross weight of:

a. 100,000 lbs or less – no additional restrictions;

b. 100,001 through 150,000 lbs – drivers shall:

i. Coordinate road closures by or under the direction of law enforcement; and

ii. Cross on center of bridge at a constant speed of no more than 10 mph while on bridge.

2. Class C permits and special analysis and approval from the Bridge Group are required for vehicles with a gross weight of 150,001 lbs or more.
